The regular monthly meeting of the Greenville Town Board was called to order by newly elected President, Ron Lamb. All board members were present. Also in attendance was Gary Getrost, Janice Gibson, Bob Isgrigg, Talbott Richardson and Paul Buche, Char miller.

The minutes of the December 8, 1987 were read and corrected to show the Edwardsville Water Co. has advised Mr. Getrost they are only contemplating raising the water rate from \$.67 to \$.92/1,000 gals., not as the minutes stated.

Claims presented to the board were approved.

Talbott Richardson requested permission to remove a curbing in front of the Clark Street property. The board approved the removal and also approved the request of Talbott for additional gravel for the parking area.

Gary Getrost stated the lake is up about 2½ feet with about 7 feet to go to be in good shape. He also stated residents on Pekin Road, currently being served by the Borden Tri-County Water Co., have complained of pressure and water odor. He stated the water quality is standard and there could be perks in the pressure.

The proposed sewer project was discussed at length; primary concern of the board being land acquisition and location of lagoons now in operation.

Mr. Isgrigg advised the board of possible land areas:

Hunt Farm, Hays Farm, Quarry, North & South of US 150, west edge of town,

and the area east of the quarry

Talbott Richardson volunteered to approach the owners of the Hunt and Hays Farm to determine their willingness to sell part of their land to the town. He also stated he would contact the proper owners of the quarry.

Ron Lamb stated he would like to have a listing of communities that have a lagoon in operation. Mr. Isgrigg advised Pekin has a lagoon type system similar to that proposed for Greenville. Also Henryville has a lagoon, but it is designed to handle solid wastes. Mr. Isgrigg stated he will check further of other areas and advise the board.

TITLE: AN EMERGENCY ORDINANCE PROVIDING FOR THE TRANSFER OF APPROPRIATIONS FOR A (SEVERAL) DEPARTMENT(S) OF THE CITY (TOWN) OF GREENVILLE, INDIANA, FOR THE YEAR 1988, AS REQUESTED BY THE DEPARTMENT HEAD(S) AND FORWARDED TO THE COMMON COUNCIL (TOWN BOARD OF TRUSTEES) FOR THEIR ACTION AND PASSAGE PURSUANT TO IC 6-1.1-18-6.

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget for the year 1988 and it is now necessary to transfer appropriations into different categories than was appropriated in the annual budget for the various functions of the several departments to meet the emergencies.

SECTION 1. BE IT ORDAINED BY THE COMMON COUNCIL (TOWN BOARD OF TRUSTEES) OF THE CITY (TOWN) OF GREENVILLE, INDIANA, that for the expenses of the City (Town) Government, the following appropriations are hereby transferred and set apart out of the funds hereinafter named for the purposes specified, subject to the laws governing the same, such sums herein transferred unless otherwise stipulated by law.

After being duly sworn in Mr. Lamb and Mr. Williams appointed Mr. H. L. Spears to serve as Trustee from the 3rd Ward.

Board members unanimously elected Mr. Ron Lamb as President of the Board.

Salary Ordinance No. 1988-01 was adopted by the board. No opposition was stated either in writing or vocally.

An ordinance establishing salaries and wages for elected officials and water utility employees for the year 1988.

WHEREAS, the Board of Trustees of the Town of Greenville, Floyd County, Indiana under the statues and codes of the State of Indiana hereby sets salaries for elected officials of the Town of Greenville and wages for employees of the Greenville Water Utility to take effect January 1, 1988.

WHEREAS, the Board of Trustees of the Town of Greenville, Floyd County, Indiana deems it necessary to establish additional positions within the Town of Greenville with additional compensation. Both town elected officials and utility employees perform duties interacting with the Town of Greenville and the Greenville Water Utility.

BE IT ORDAINED, that salaries and wages listed below shall be effective as above and paid from various funds as noted below.

- 1. Salary of the President of the Board shall be \$1,320 per year. Salary of Board Members (2) shall be \$1,080 per year. Salary of The Clerk-Treasurer shall be \$1,800 per year.
- 2. The sum of \$1,440 (\$360, \$240, \$240, Board of Trustees and \$600 Clerk-Treasurer) per year shall be paid from the Town General Fund.
- 3. The sum of \$3,840 per year shall be paid from Water Utility Funds. (\$960, \$840, \$840 Board Members, and \$1,200 Clerk-Treasurer).
- 4. The Board of Trustees establishes the position of Manager, Town/ Water Utility, for which Gary Getrost is appointed. Salary shall be \$22,060 per year with \$589 paid from Town General Fund and \$21,471 paid from Water Utility Funds.
- 5. The Board of Trustees appoints Janice Gibson as Office Manager/Utility and Administrative Clerk/Town at a salary of \$15,597 per year with \$300 paid from Town General Fund and \$15,297 paid from utility funds,
- Salary of utility employee V. J. Miller shall be \$12,136 per year paid from Water Utility Funds. Additional labor performed for the Town of Greenville shall be paid at the rate of \$5.83 per hour.
- 7. Salary of utility employee Scott Ham shall be \$11,440 per year paid from Water Utility Funds. Additional labor performed for the Town of Greenville shall be paid at the rate of \$5.50 per hour.
- 8. Wages and salaries paid from town funds shall be paid monthly, and from Water Utility Funds on a weekly basis.

FURTHER, the salaries of Town/Utility employees may be changed during the year upon the recommendation of the Manager, Town/Utility and/or the Board of Trustees.
