Minutes of Greenville Town Council Meeting July 10th, 2017

President Greg Redden called the regular monthly meeting to order. Other Councilpersons present were, Keith Johnson, David Gomes, and Darryl Kepley along with Clerk Jack Travillian. Also attending the meeting were Water Superintendent Steven Schmitt, and several concerned citizens. The meeting was opened with a prayer from Pastor Mark Avery followed by the Pledge of Allegiance.

Minutes: The minutes for June 12th regular meeting were discussed. Motion was made by Councilman Johnson and seconded by Councilman Gomes to accept the minutes. Motion passed 4-0.

Marshal Report:

Marshal Craig noted a change to Indiana statue that requires workman's comprehensive coverage for all reserve officers. Clerk Travillian advised that the insurance agent had already briefed him on the changes and was working on the coverage.

Marshal Craig requested ammo for the marshal's department. There is a need for rifle and pistol ammunition both for training and duty. Motion made by President Redden and seconded by Councilman Johnson to purchase 1,000 training rifle and pistol, 500 rifle duty and 100 pistol duty. Motion passed (4-0). The marshal can select where to purchase, not to exceed \$1,100 coming from Riverboat Fund.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The checks were approved without objections.

2017-TR-018 Transfer of Funds: Second reading of ordinance to transfer \$2,000 from Motor Vehicle Fund – Snow Removal transfer to General Fund Marshal's Fuel, and to Transfer \$1,000 from Motor Vehicle Fund – Snow Removal to Motor Vehicle Fund – Telephone Account. Motion was made by Councilman Johnson and seconded by Councilman Kepley. Motion passed 4-0. Third reading was completed. Motion made by Councilman Johnson and seconded by Councilman Kepley. Motion passed 4-0.

Clerk Travillian suggested transferring funds from General Operating into Special Projects Fund. The ordinance will be ready for next month's meeting.

Committee Reports:

Special Projects:

Councilman Lemon was not present but had updated the council about the website being updated and now the Greenville Municipal Utilities can take payments via credit cards on the town site.

Streets and Roads:

Councilman Kepley reported that the Parkland Heights project and the Right of Way cleanup along Harrison Street has been completed.

Motion was made by Councilman Kepley and seconded by Councilman Johnson to complete the drainage project on Clark Street – not to exceed \$3,000. Motion passed 4-0.

Utility Business:

Superintendent Schmitt gave the monthly adjustment report. The council accepted the adjustments without comment.

Employee Chrystal Robb is now off on extended leave after giving birth to a baby son.

The new body bed for the Silverado is being prepared and will be black due to having issues trying to match the grey tone of the original truck body. The council asked to have the old body put toward the new truck being purchased.

New Truck:

Bids for the replacement truck from Ford – F150 \$25,391.64, Toyota - \$29,439.79 and Chevy Colorado - \$26,149 from John Jones. Motion was made to purchase the Chevrolet Colorado by President Redden and seconded by Councilman Kepley. Motion passed 4-0.

Sewage Plant:

Superintendent Schmitt reported that there was repairs needed to the sewage pump that had just been refurbished due to some type of rope that was taken into the intake and caused damage. The solid waste will need to be pumped soon.

Other Business:

CLERK / TREASURER

The resident on Pekin Road wanted an update on the drainage issues. The council is waiting on the survey that was to be completed, noting that we cannot do work on private property, it is the responsibility of the owner. The council will follow up with Floyd County Road Department.

No further business coming before the Council, motion made by Councilman Johnson and seconded by Councilman Kepley, passed 4-0, the meeting was adjourned.
