# Minutes of Greenville Town Council Meeting August 14<sup>th</sup>, 2017

President Greg Redden called the regular monthly meeting to order. Other Councilpersons present were, Keith Johnson, and David Gomes along with Clerk Jack Travillian. Also attending the meeting were Water Superintendent Steven Schmitt, Town Attorney Heather Peters and several concerned citizens. The meeting was opened with a prayer from President Redden followed by the Pledge of Allegiance.

**Minutes:** The minutes for July 10<sup>th</sup> regular meeting were discussed. Motion was made by President Redden and seconded by Councilman Johnson to accept the minutes. Motion passed 3-0.

#### Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The checks were approved without objections. There was questions about Sewer Utility checks and balance in account at this time.

The pre-budget for 2018 was presented to the council and will be published within 10 days. The first meeting for the budget will be on September 11, 2017 with final budget meeting being held on October 9, 2017.

### Marshal Report:

Marshal Craig noted that the department was giving free body cameras. The first year is at no cost then there will be annual maintenance and upgrade charges.

Marshal Craig has been in contact with Floyd County that will be issuing a check for tickets written. The marshal also requested to check on life insurance for the part-time officers.

## **Committee Reports:**

### **Special Projects:**

Greenville Historical Preservation Commission: The council reviewed an application to join the commission. Motion was made by President Redden and seconded by Councilman Johnson to appoint Kim Hardin to the commission. Motion passed 3-0.

#### Streets and Roads:

Councilman Kepley reported that the Parkland Heights right of way tree and bush trimming cleanup has been completed.

The council is reviewing a proposed contract with New Albany/Floyd County Animal control due to concern about animal care issues.

## **Property Cleanup:**

The council has received several complaints through the Town website and is sending out letters requiring properties to get in compliance, including some Heritage Springs subdivision vacant properties.

# **Utility Business:**

Superintendent Schmitt gave the monthly adjustment report. The council accepted the adjustments without comment. There has been very few leaks corrected this month.

Superintendent Schmitt reports being contacted about possible new subdivisions and utility hookups, water and possibly sewage.

Superintendent Schmitt has hired a new full time person, promoting the part-time employee and has advertised new part-time open position.

## **Sewage Plant:**

Town Attorney Peters was asked about the adjacent property for the sewage plant and will contact Thieneman attorney about the bid process.

No further business coming before the Council, motion made by Councilman Johnson and seconded by President Redden, passed 3-0, the meeting was adjourned.
