**ORDINANCE CONCERNING THE REGULATING OF CUTTING
THROUGH PARKING LOTS TO AVOID TRAFFIC BACK-UPS WITHIN
THE TOWN OF GREENVILLE, INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana, in the interest of public safety, health and welfare has deemed it necessary to develop a Traffic Ordinance regulating cutting through parking lots to avoid traffic back-ups within the Corporate limits of the Town of Greenville;


NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. It shall be deemed a traffic violation by the Town of Greenville Council and enforceable by the Greenville Marshal Department to operate a motorized vehicle of any type across any parking lots, sidewalks or curbs to avoid traffic back-up at any roadway or roadway intersection within the Corporate limits of the Town of Greenville.
2. A traffic citation fine of Fifty U.S. Dollars {\$50.00} shall be issued by the Greenville Marshal Department for any individual in violation of this Ordinance.
3. Exemptions from this Ordinance;
 - Lawn tractor equipment.
 - When being directed to do so by a Greenville Marshal or Auxiliary Department Member in the case of an accident or natural disaster.
4. This Ordinance shall be effective upon its passage by the Greenville Town Council and publication in the New Albany Tribune of New Albany, Indiana.
5. The Town of Greenville Clerk Treasurer shall publish this Ordinance within 30 days in the New Albany Tribune after passage.
6. The Town of Greenville Clerk Treasurer shall attach a copy of the publication and related information to the original signed Ordinance and a PDF file shall be added to the electronic file copy of this Ordinance.
