## CONFRIMING RESOLUTION CONCERNING THE REINSTATMENT OF FUNDS RECEIVED FOR ACCOUNT NUMBER 55039 DECLARED AS A BAD DEBT DECEMBER 18<sup>TH</sup>, 2009 BY THE TOWN OF GREENVILLE, INDIANA WATER UTILITY COUNCIL
