**ORDINANCE 2018-TO-001 -
ORDINANCE PROHIBITING
SNIPES SIGNS**

WHEREAS, the Town of Greenville, Indiana, in the interest of public health, safety and welfare, has deemed it necessary that the Town develop an Ordinance that forbids snipe signs within the corporate limits of the Town of Greenville.

WHEREAS, the Town of Greenville, Indiana, continues to preserve the community appearance and beautification efforts within the corporate limits of the Town of Greenville.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

Section 1. Definitions

"Sign". A name, display, identification, device, notice, figure, painting, drawing, message, placard, poster, word, bulletin board, symbol, letter, numeral, emblem, trademark, flag, or banner, pennant, or other illustration which is affixed to or painted or represented directly or indirectly upon a building or other outdoor surface, or parcel of land and which directs attention to an object, product, place, activity, person, institution, organization, or business, and is visible from any alley, street, highway, sidewalk, or other public way, whether such is placed out of doors or in windows. The term sign does not include any display of official notices of courts or other Article IX, § 5 of 21 public offices, nor the flag, emblem or insignia of a nation, political unit, school, or religious group. The term "sign" shall not include the merchandise, which is for sale on the premises, the packaging or container for such merchandise, or any writings or other symbols on such merchandise, container, or packaging.

"Snipe Sign". Any sign (whether attached in any way to a utility pole, tree, traffic control device, or any object, or the ground, or otherwise situated) on (a) public property without the consent of the appropriate public body or (b) private property without the consent of the owner or occupier thereof.

Section 2. Prohibition of Snipe Signs

Snipe signs are hereby expressly prohibited as to erection, construction, creation, maintenance, repair, alteration, location, or relocation within the Town. No sign or sign structure shall be affixed to, displayed, or located upon any utility pole, light standard, traffic control device or located upon any public right-of-way, utility easement, or other public property.

Section 3. Prohibition for Height of Snipe Signs

Snipe signs located higher than five (5) feet from the ground require additional resources from the Town for removal; therefore, any snipe sign located higher than five (5) feet from the ground will be subject to the maximum penalty as set forth in Section 7.

Section 4. Confiscation of Snipe Signs

In addition to any and all other remedies set forth in this Ordinance for a violation thereof, Town Council Members, their designees, and all employees for the Town of Greenville may remove any snipe sign and confiscate it.

Section 6. Enforcement

Unless circumstances clearly show otherwise, the following presumptions exist in connection with any snipe sign which violates any provision of this ordinance: (1) the sign was erected at its location with consent of the company or business advertised thereon and (2) the sign was erected by, or with the consent of, the promoter of the sign or event advertised thereon. In the case of "maid services", the company or promoter thereof.

Section 6. Notice of Violation

The Town shall contact those which violate any provision of this ordinance by using the means of contact provided on the prohibited Snipe Sign (i.e. phone number, email, etc.). Once the contact is made with the company, they will be given 72 hours to bring the sign(s) in to compliance. If the sign has already been confiscated by the Town of Greenville, violators will be required to pick up the prohibited sign(s) from the Town within 72 hours or be subject to the penalties set forth in Section 7.

Section 7. Penalty

A Fifty Dollar (\$50.00) fine will be assessed for each sign violating a provision of this ordinance with a maximum fine of Five Hundred Dollars (\$500.00).
