

ORDINANCE CONCERNING PLACEMENT AND SCREENING
OF TRASH RECEPTACLES

WHEREAS, the Town of Council of the Town of Greenville Indiana, in the interest of public health, safety and welfare, has deemed it necessary that the Town of Greenville adopt an Ordinance regarding the Placement and Screening of Dumpsters within the Corporate Limits of the Town of Greenville, Indiana and pursuant to I.C. 36-5-2-9

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. "Dumpster" means a receptacle container that has a hooking mechanism that allows it to be raised and dumped into a sanitation truck, including dumpsters for trash, compacted materials, and recycling.
2. All dumpsters must be screened on all sides by a fence, gate or wall. The material used for the screen must be made of the same material as the primary surrounding structures. Glass or similar translucent materials shall not be used. Such screening shall be a minimum of six (6) feet in height and a maximum of eight (8) feet in height.
3. The fourth side which provides access to the dumpster for refuse collectors shall be gated and situated so that the container is not visible from adjacent public streets.
4. Location. Outdoor trash receptacles, dumpsters, recycling containers, compactors, and similar containers shall be placed on an improved surface
5. Setbacks. Outdoor trash receptacle, recycling containers, dumpster, compactor, and similar container enclosures shall meet the setback requirements in 2010-T-050 for Storage Buildings, Pool Houses and Gazebos, and shall not be placed within a front or side yard.
6. Protected and Maintained Screened outdoor storage facilities shall be properly maintained and kept in good repair at all times.
7. No trash shall be overflowing from the dumpster from the confines of the storage facility. Dumpster gates shall remain closed at all times, excepting those times when trash is being placed in said dumpster.
8. All signage affixed to any screening must be of professional quality and limited to two signs.
9. The screening described in paragraph 2 of this Ordinance must be permitted in the same manner as any other structure in the Town Limits as described 2010-T-050.
10. Enforcement of this ordinance shall be made by the Greenville Marshall or the Greenville Town Attorney by giving notice to the owner of the property. Any dumpster or screening not in compliance with this ordinance shall be fined \$50.00 per day for each day that the dumpster is not in compliance with any part of this ordinance, beginning on the 10th day after notice of the violation. Such fines shall be reduced to judgment if not paid within thirty (30) days after the Notice of Violation.
