## Ordinance No. 2023-TO-018

Whereas, Counties, Cities, and Towns each received an allocation of Coronavirus State and Local Fiscal Recovery Funds.

Whereas, a separate fund named the ARP Coronavirus Local Fiscal Recovery Fund (Fund Range 176-199) was created by the Town by Ordnance 2021-TO-0007, for use as described in the Social Security Act Section 603(c) as added by Section 9901 of the American Rescue Plan Act of 2021.

Whereas Section 603(c)(C) of the Act specifically includes the use of ARP Funds for "government services to the extent od the reduction in revenue of such metropolitan city, nonentitlement unit of local government, or county due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year of the metropolitan city, nonentitlement unit of local government, or county prior to the emergency;"

Whereas, the Town by Amendment of Ordinance 2021-TO-0007 has identified in its American Recovery Act plan "Recoupment of lost revenue and tax receipts due to the Coronavirus" as a permissible and priority expenditure of plan funds.

SECTION 1. BE IT ORDAINED BY THE TOWN COUNCIL OF GREENVILLE, INDIANA, that for the expenses of the Town Government, the following appropriations are hereby transferred and set apart out of the funds hereinafter named for the purposes specified, subject to the laws governing the same, such sums herein transferred unless otherwise stipulated by law.
