Minutes of Greenville Town Council Meeting July 10th, 2023

Monthly Meeting:

President Greg Lemon called the regular monthly meeting to order. Other Councilperson present were Andy Lemon, David Gomes, and Skip Powell along with Town Attorney Heather Peters, also present was Superintendent Audi Findley along with Clerk Jack Travillian. Other concerned citizens were also present. The meeting was opened with the Pledge of Allegiance.

Town Business:

Minutes: Motion made by Councilman Lemon and seconded by Councilman Gomes to accept the minutes for May and June 2023. Motion passed 4-0.

Police Department: Chief Craig announced assembly of the new police vehicle will start on August 20. Chief Craig presented a bid to add the police package from Waymire Group for \$21,667.14. Motion made by Councilman Lemon and seconded by Councilman Powell. Motion passed 4-0. Funds will be taken from the ARP Funds.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The monthly checks were approved.

Committee Reports:

Emergency Services:

Councilman Gomes reported that the Floyd County Sheriff Department has postponed weapons exchange so the police department will wait to be compatible when this is completed.

Streets and Roads:

The Community Crossing Grant has been completed for the town streets. Councilman Lemon will be starting the pot-hole blitz soon.

Councilman Powell will get estimates on installing speed humps through the town subdivisions from C&R.

Attorney's Report:

Attorney Peters will be reviewing parking restrictions from other local communities to make recommendations on a comprehensive ordinance for Greenville.

2023-TO-009 ORDINANCE CONCERNING INCLUSTION OF THE TOWN OF GREENVILLE IN THE HIGHLANDER FIRE PROTECTION DISTRICT:

Motion by President Redden and seconded by Councilman Powell for unanimous consent. Motion passed 4-0

The town has received a request for a permit to install a pool in Heritage Springs subdivision, this should be forwarded to Floyd County building commission, which handles permits for the Town of Greenville.

ORDINANCE 2023-TO-007 ORDIANANCE FOR WAGES OF THE TOWN OF GREENVILLE FOR CLERK/TREASURER 2024: Motion was made by President Redden and seconded by Councilman Powell for unanimous consent to increase salary for Greenville Town Clerk/Treasurer. Motion passed 4-0.

Motion by President Redden and second by Councilman Lemon to close town business, motion passed 4-0.

Utility Business:

Water Utility

Superintendent Audi Findley the leaks adjustments reviewed were accepted. Last month's water loss was lowered to 19%.

Indian Creek project: E&B will be doing the boring for the replacing water main along side of Highway 150 under Indian Creek. This project is on hold until the lane closure for bridge reconditioning moves to the East bound lanes due to safety issues.

Greenville Water Utility is now in contract to complete the lead and copper inventory of all lines including residential customers and will be sending out questionnaires to help lower the cost of the inspections.

Superintendent Findley last day will be June 30th. Superintendent Findley will be working part time for 20 hours per week at half salary until the new superintendent is in place.

Sewer Utility:

Jecker Excavating & Septic has completed the system jetting and pressure washing of the manholes for preventive maintenance in the Heritage Springs Wastewater Treatment system.

PLC replacement and update at Heritage Springs Wastewater Treatment plant is now estimated at around \$100,000.

CRYSTAL ROBB: Crystal Robb is being promoted to Office Manager. Reading or ordinance completed, motion was made for unanimous consent by Councilman Lemon seconded by President Redden. Motion passed 4-0.

Motion passed 4-0.
