The regular monthly meeting of the Greenville Town Board, held this date, was called to order by Ron Lamb in the absence of President H. L. Spears. Those in attendance were Board member Jack Sprigler, Janice Gibson, Gary Getrost, and Talbotte Richardson.

Jack Sprigler moved to dispense with the reading of the minutes. Financial statements and claims were presented to the Board. The claims were approved and financial statements accepted by the Board.

The Board discussed the opening of a car lot by Terry Hunt on the property owned by Elwinger on Hwy 150 and Voiles Road. The Board said the view for vehicles turning onto the highway cannot be blocked.

Jack Sprigler moved that a device for measuring streets be purchased by the Water Utility. Ron Lamb seconded. The streets need to be measured and the information sent to the State so the Town can get the proper amount of money for the streets.

Andy VanWinkle prepared a map for the Board with proposed house/lot numbers.

The Board established Harrison County Bank and First Midwest Bank and Trust as depositories for the Town and Utility.

The Board reconsidered the claim of Clark Cooke for water damage to his basement and its contents, and agreed to pay him \$550.00.

The Board agreed that after March 22, V. J. Miller earns an additional week of vacation.

Gary Getrost reported that Fred Grauel had contacted the WAVE TV 3 Trouble Shooter about not being able to get water from Greenville Water Utility. Gary talked to the trouble shooter and informed him of the utilities position in the matter.

Dirty water has been reported on Pekin Road. It is coming from Borden through the connection on Pekin Road.

Concerning the proposed connection with Floyds Knobs Water Co. on Smith Road: Gary reports they know have the easements and are ready to come to talk to us again about details.


The Board approved the purchase of a Xerox 1012 R/E copy machine.

Jack Sprigler moved the meeting be adjourned.

I am writing this letter to ask if you can help my family get fresh water into our house. We are the only family on Coffman Rd. in Greenville, In. that doesn't have Greenville Water because they won't run us a service.

We are now using well water that has five different colonies of bacteria in it. We are a family of four and would like our right as a tax paying citizen of Floyd county to have fresh water. We've been trying to get water for five years now. Our neighbor, who works for the Floyd County School System that my two children attend, denies us an easment to receive fresh water, and the Greenville Water Company says they have no obligation to run us fresh water.

We would sure be glad to have your help in this matter, as we have tried all other avenues. It is such a shame for us not to have fresh water in our home, when it is readily available. Please contact us "preferibly" in person or by phone as you need to see our problem to understand it completely.

was sent to the WAVE TROUBLE SHOOTER on 2/2/87. We would appreciate information from you concerning your position on this complaint.


