# MINUTES OF BOARD OF TRUSTEES, TOWN OF GREENVILLE

Ron Lamb, President of the Board, called the meeting to order. All board members were present. Also in attendance was Gary Getrost, Bob Isgrigg, Talbott Richardson, Mildred Bierman, William Roberts and his son.

Buck Spears motioned for approval of the  $\mbox{\sc April}$  12 minutes, seconded by  $\mbox{\sc Ron}$  Lamb.

Financial reports was presented to board members. Bank balances for the Town of Greenville and Greenville Water Utility are in agreement with the Bank balances for the month.

Ordinances vacating certain alleys within the Town of Greenville were given necessary readings. There being no objections from those present or in writing, and being duly advertised, the Ordinances were approved.

Mr. Roberts, owner of the lodge building in Greenville advised the board of his intention to repair the roof of the building damaged by storm during December 1987. His plans call for rmoving the third (3rd) floor and installing a new roof. Ron Lamb stated Roberts should notify the state of their plans; notify the Greenville Town Marshall, should the town sreet be closed during repair; and the contractor be bonded. Mr. Roberts agreed to these stipulations.

Mildred Bierman enlightened the board on the current status of her proposed subdivision. Her concern at this meeting was that of line size. Gary Getrost stated a 3" line is sufficient to serve the area if no further expansion is contemplated, but cautioned her Floyd County Planning may require fire hydrants and if this is the case a six (6") inch line will be necessary.

Ms. Bierman expressed concern as to the cost of such line. Mr. Getrost advised her the current cost of 3" pipe is \$.73/ft. and 6" pipe is priced at \$2.37/ft.; but that quantity purchases should reduce this cost. Ron Lamb advised Ms. Bierman there is no need to return to board meetings since the board previously stated their position to supply water to the area as future questions should be directed to Gary Getrost, Utility Manager.

Bob Isgrigg, Town & Utility engineer advised the board he is still in the process of contacting home owners in the area on the possiblity of a lagoon site.

The board expressed concern of the utilitys' ability to supply water to the township under current conditions. To enable the board to make informed decisions on such matters as line extensions, water quality, etc., the board requested Mr. Isgrigg to study the needs of the Utility as to water availability, future requirements, plant upgrade, etc.
