May 14, 1979 Town Hall

The regular monthly meeting of the Greenville Town Board was called to order by President Robert Gibson. Those in attendance were all board members along with Messers. Bob Isgrigg, V. Ham, J. Gibson, William Neal, and Charles Bickel and G. Getrost.

Minutes of the previous month meeting were read and approved. The board was advised of the financial condition of the Town and Water Utility. Balances of the accounts for period ended April 30, 1979 is as follows: General account - \$6,321.83; MVH \$22,640.24; C.C.I. \$12,699.82; L.R.&S. \$9.743.06; Anti-Recession \$261.00; Revenue Sharing \$3,958.48 and C.E.T.A. \$384.94.

Mr. William Neal complained about the water pressure around his property which is located in the Pekin Road area. He stated that approximately 22 homes are on a 2" line which he believes is not sufficient for that number of users. He stated the water has been dirty also. Mr. Neal stated the water pressure runs from 0-22 lbs. but most of the time is it is around 15 lbs. and that a larger line is needed. Mr. Gibson stated the utility would take appropriate action to correct the situation.

Mr. Larry Conrad complained of water drainage around his property. Mr. Gibson advised him to contact county officials concerning this problem. He also complained about irregular water bills dus to different times at which the meter is read, causing him to pay additional sums. Mr. Gibson advised him correction would be made and that regular readings would be made.

Mr. Charles Bickel requested from the board a committment that the Water Utility will provide water for his proposed subdivision project. The board stated the utility would provide service to three (3) homes during 1979, three (3) during 1980 and the remainder during 1981. A letter of intent will be furnished to Mr. Bickel.

Mr. Isgrigg presented the board with plans for the Treatment Plant Improvements and improvements to the lines.

The board passed and ordnance annexing property on Buttontown Road belonging to Jean and Sharon Haub, adjoining the property of the Greenville Fire Department. (Attached. All board members voted "aye" to the proposed ordnance.

The board approved an increase in salary for Ms. Dowell from \$3.00 to \$3.25 per hour.

The board also authorized Mrs. H. Miller to drill under 1st street for purpose of extending drainage lines.

No further business coming before the board, Mr. Gibson motioned for adjournment, seconded by Pearl Tush.

#### SPECIAL ORDINANCE OF THE TOWN BOAND OF THE TOWN OF GREENVILLE, FLOYD COUNTY, INDIANA ARREXING CERTAIN TERRITORY

WHEREAS, pursuant to the provisions of I.C. 1971, 13-5-10-30, Merlyn Haub and Sharon Haub have petitioned the Town Board of the Town of Greenville, Floyd County, Indiana, for the annexation of the following described real estate, which lies adjacent to but outside of the present corporate boundaries of the Town, to-wit:

Commencing at the Southeast corner of the Southwest Quarter of Section 5, Township 2 South, Range 5 East, and running thence north with the east line of said southwest quarter and the center line of Buttontown Road, a distance of 1870.00 feet to a railroad spike; thence west 208.70 feet to an iron pipe, the true place of beginning of the tract to be herein described; thence continuing west, a distance of 426.90 feet to an iron pipe; thence north 463.00 feet to an iron pipe; thence east 620.60 feet, more or less, to a point on the west right of way line of Buttontown Road; thence southwardly with said west right of way line, a distance of 100 feet to a point; thence west with the north line of a 1.739 acre tract heretofore conveyed to Harvey L. Taylor and Virgie L. whereas, the Town Board of Greenville has determined that the real estate which is the subject of this Petition does not lie in any county or counties other than the County of Floyd, State of Indiana; does not lie within three (3) miles of any point on the perimeter of the boundaries of the Civil City of New Albany, Floyd County, Indiana, being the only second class City located within said County; and, has determined that one-fourth of the aggregate external boundary of the above described tract is bordered by the present boundaries of the Town; and

WHEREAS, the Town Board has determined that governmental and proprietary services substantially equivalent in standard and scope to the governmental and proprietary services furnished by the Town of Greenville to other areas of the Town can be furnished to the area to be annexed within three (3) years of the date of this Petition, if not sooner, namely, fire protection, police protection and water services to be provided by Greenville Water Utility; and

WHEREAS, the Board has determined, by unanimous consent and by unanimous vote that the best interests of the Town will be served by granting the Petition for annexation.

#### NOW THEREFORE:

BE IT ORDAINED, that the following described 5.017 acre tract, as more particularly shown upon the survey attached hereto and made a part hereof as Exhibit "A", be, and the same hereby is, annexed into the corporate limits of the Town of Greenville, Floyd County, Indiana:

Commencing at the Southeast corner of the Southwest Quarter of Section 5, Township 2 South, Range 5 East, and running thence north with the east line of said southwest

quarter and the center line of Buttontown Road, a distance of 1870.00 feet to a railroad spike; thence west 208.70 feet to an iron pipe, the true place of beginning of the tract to be herein described; thence continuing west, a distance of 426.90 feet to an iron pipe; thence north 463.00 feet to an iron pipe; thence east 620.60 feet, more or less, to a point on the west right of way line of Buttontown Road; thence southwardly with said west right of way line, a distance of 100 feet to a point; thence west with the north line of a 1.739 acre tract heretofore conveyed to Harvey L. Taylor and Virgie L.
