MINUTES OF GREENVILLE TOWN COUNCIL MEETING, July 9, 1996.

The regular monthly meeting of the Greenville Town Council was called to order by Council President Janet Riggs at 7:30 P.M.

Minutes of the June meeting was read by Councilmember Ted Miller. On motion of Councilmember Mike Receveur to approve the minutes as read, seconded by Ray Gibson, President Riggs moved to declare the minutes approved.

Council directed the Clerk Treasurer to contact the Floyd County Surveyor regarding having an alley surveyed (W. 3rd St.) to determine it's boundaries.

Councilmembers Gibson and Receveur advised the Council that numerous streets/ alleys are overgrown with weed and overhanging tree limbs that they believe creates a safety hazard. Council President Riggs stated this situation is considered an emergency. Council agreed, approving the declaration by unanimous vote. Council agreed to proceed to cut and prune the areas involved.

Floyd County Commissioner Bill Burkhart advised the Council of road projects status within the area of the Town of Greenville.

The Council discussed various issues coming before the Council before adjourning at 10:00 P.M. on motion by Ted Miller, seconded by Ray Gibson.
