MINUTES OF TOWN COUNCIL MEETING
August 12, 2002

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller, with Council Members David Matthews, Hanzel Barclay, Leon R. Gibson and Mike Receveur present as was Clerk Treasurer Jack Sprigler.

Also attending was Town Utility Attorney Jef Fifer, Utility Supt. Gary Getrost, Janice Gibson, Sheila Moore and John Hockensmith.

Leon Gibson motioned the Council dispense with the reading of the July minutes and to approve the minutes as written (after review by each Council Member). On a vote of the Council the minutes were approved 5-0.

Attorney Jef Fifer read Ordinance G2002-T-017 titled "Ordinance of Annexation", more particularly described as 6437 Buttontown Road.

Ted Miller motioned the Council consider Ordinance G2002-T-017 with Mike Receveur motioning to accept. After review by the Council Miller asked for a vote by the members. On call of the roll all members voted "aye". Miller then declared Ordinance G2002-T-017 Titled "Ordinance of Annexation" duly passed by the Greenville Town Council.

Council also addressed several issues such as:

Ordinance Violation (David Matthews will notify by letter & include copy of ordinance).
Terwilleger/Stacy Printing dispute - Council feels this dispute should be solved by them.

Gary Getrost advised the Council of pending water rate increases by Ramsey Water Co. and Floyds Knobs Water Co. He also stated the Utility needs additional storage capacity. In order to solve this problem Gary stated an engineering study is needed for land acquisition, contractors, financing etc.

Council approved (5-0): Claims for the Town & Utility
Water bill adjustments
Marshal's bond and premium payment.
Continuing education for the Marshal in
the amount not to exceed \$300, disbursed
from the Law Enforcement Continuing
Education Fund.




