The regular monthly meeting of the Greenville Town Board was held here on this date. The meeting was opened by President of the Board Jack Sprigler. All members of the Board were present, also Sue Snyder, Gary Getrost Talbotte Richardson and other interested parties.

Minutes of the previous meeting were approved. Financial statements were presented to each board member.

Bill Neeld asked that the water problems on Pekin Rd. be corrected. Motion was made by V.J. Miller and seconded by Jack Sprigler to start proceedings on installing a 4in. or 6in. line Dan Cristiani to be contacted about this.

Snyder Backhoe was paid in full for Waterline improvement this last payment was in the amount of \$15645.13 . Received also were letters of release from Sub-contractors, work, labor and material. Snyder Backhoe is responsible for all work and clean-up for one year from April of 1981.

The board approved Ray Huckleberry's return to work, Monday August 17, 1981. V.J. Miller made the motion Jack Sprigler seconded it. Motion was also made by V.J. Miller and seconded by H.L. Spears to require a Physical Examination for all new Employees. ^{work}
The board approved three ^{work} days per month for Mayola Evans, motion by Jack Sprigler seconded by V.J. Miller.

Talbotte Richardson reported on Water Tower, there is a stress buckle in the tank that needs to be watched. Bartron's bid on the Galena Tower is \$11,500. He will give cost on painting the Base of the Greenville Tower.

Talbotte Richardson, Town Marshall is to contact the State Police on the contradiction of speed limit signs within the Town, he will also have a notice in the paper that the ~~20~~ mile speed limit will be enforced when School starts.

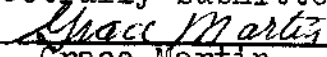

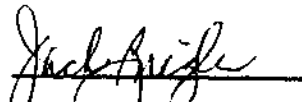
Purchasing orders are to be used for all purchasing with Gary Getrosts' signature only.
