The regular monthly meeting of the Greenville Town Board, held this date, was called to order by President H. L. Spears. All Board members were present. Also in attendance: Bob Isgrigg, Janice Gibson, Gary Getrost, V.J. Miller, Talbotte Richardson and Marvin Powell.

Financial statements were presented to the board. The statements, claims and minutes of the previous meeting were accepted by the Board.

Plans for the Featheringill Rd. water line extension have been submitted to the State for approval. Isgrigg will inspect installation of the line.

The New Albany-Floyd County Health Department has given Carl Elwanger permission to use existing septic system on the northeast corner of Voyles Rd. and U.S. 150. He agreed to repair any defects that may occur.

Isgrigg will inquire if any funding is available for moving the water lines on U.S. 150 at Indian Creek.

Joe Roudenbush will mow town weeds for \$10/hour.

Jeff Varner now owns the basement property on the west end of Clark St. He lives at 717 W. Market St. in New Albany. The Board discussed the possibility of placing a lien on the property.



Richardson asked the Board if there was money available for uniforms. They approved the purchase of one for himself and Powell.


Gibson reported the Water Company purchased a \$30,000 C.D. - \$2000 from the meter deposit fund and \$28,000 from the operating fund.
