## MINUTES - TOWN COUNCIL TOWN OF GREENVILLE September 8, 2003

The regular monthly meeting of the Greenville Town Council was called to order by Council President L. Ray Gibson at 7:30 P.M. with Council Members H. Barclay, Ted Miller and Clerk Jack Sprigler present; Council Member David Matthews was absent. Also attending was Gary Getrost (Utility Supt.), Marshal David Moore, Jef Fifer and Denise Franke (Fifer Law Office), Don Thieneman and his attorney Greg Fifer, Bob Tilly, Ms. Jenkins, Mr. & Mrs. Robert Marcum, and other interested persons.

Minutes of the August meeting was approved (3-0) on motion by Ted Miller.

Mike Receveur moved from his Ward (2) at the end of August therefore making him inelgible for the position of Council Member. Mr. Gibson thanked him for his pastperformance as a Council Member and the Council wished him success.

Gary Getrost advised the Council he and the Utility engineer were pursuing the water availability study and that at the present time the study was in a holding pattern subject to additional information. Gary said he informed our major suppliers of Greenville's needs. Mr. Miller questioned whether a new contract with Edwardsville Water is neededthat Greenville should be able to buy water from any source. Jef Fifer stated he did notbelieve FMHa would approve a new contract for water supply. Mr. Fifer stated he would check into the matter further.

Greg Fifer, Attorney for Thieneman questioned if the Greenville/Edwardsville Water contract has a cap. Miller stated there is a cap. Fifer stated he believes Greenville has the capacity to provide water to Thieneman's project. Until the water study is completed Mr. Gibson advised Fifer & Thieneman the Council will keep them posted on the progress.

Bob Tilly complained his neighbor was blocking a water flow on his property. Council advised him that since the matter was on private land he should seek legal counsel. (See Attachment #1).

Council by a vote of 3-0 authorized Fifer Law Office to pursue further legal action against Mr. Meador regarding his property on the Gre/Geo. Rd.

Mr. Don Lopp and Ms. Jill Saegesser, River Hills Planning Comm. explained to the Council their involvement for the Town of Greenville.

Mr. & Mrs. Robert Marcum advised the Council they were considering purchasing property along US 150 for a Hair Salon. The Council stated they would not object providing they observed the Town's building codes. (See Attachment #2).


Council approved (3-0) claims for the Town and Utility&Water Bill Adjustments.

Water availability

I am concerned that infrastructure is not in place to serve present and future Greenville Water Company customers. Indiana is part of a ten-state ruling by the fresh water Division of IDEM that requires water utilities to have storage for one day's supply of water.

Currently, Greenville Water's two towers, a 100,000-gallon tank in Greenville and a 60,000-gallon tank in Galena, do not have the capacity to store a 24-hour supply of water. There are about 10 hours of water storage capacity from January to July (based on the 2003 average of 388,600 gallons usage per day); and about seven hours of storage during the drier summer months (based on the 2003 average of 426,000 gallons of usage). We may be able to store our water in towers owned by other water companies, but will the aggregate storage requirements of the companies involved meet IDEM requirements? The ruling was established to prevent emergency conditions. It would be a sad situation if a practice of sharing caused a water disaster such as the power outage we just witnessed when eight states were without electricity.


What about water capacity, itself? I can remember times, some not too far in the past, when water was low and a water alert prevented watering lawns, filling pools, etc. And I sympathize with my friends in Georgetown, who often can't use their water at all, or must boil it before drinking it. It is nice to have water available and to be able to wash clothes without muddy wash water.

Greenville's water usage has increased 51% in the last 10 years. How much will it increase in the future? Adding a few developments, such as the 200+home subdivision being proposed in Greenville, could make a big difference in the water quality and quality of life experienced by Greenville's present residents and water company customers.
