Minutes of Greenville Town Council Meeting October 9, 2006

President Talbotte Richardson called the regular monthly meeting to order. Councilpersons present were Hanzel Barclay, Janet Wright, David Moore, and President Talbotte Richardson, along with Clerk Jack Travillian. Also attending the meeting was Town Attorney Rick Fox, Greenville Water Utility Superintendent Gary Getrost, and other concerned citizens.

Assistant Chaplain Mike Mosier opened the meeting with a prayer. Minutes were read and approved. T. Richardson made the motion and J. Wright seconded. (Motion passed \$\frac{\psi}{2}\$)

Resolution 2006-T-65 Citizen of the year 2006 – Seibert Dodge was presented with citizen of the year for 2006 for all the years of active participation in civic events including float building for parades in previous years. Mr. Dodge is an inspiration to all citizens and this award was very overdue, noted President Richardson.

Ordinances: Ordinance 2006-T-58 Noise Nuisance – Attorney Fox presented the council with the proposed nuisance ordinance 2006-T-58. First reading was done then motion was made by councilman Moore and seconded by councilwomen Wright to accept the ordinance with only one amendment changing the time from 10 AM to 9 AM for beginning hour. The council unanimously voted to have second reading. Second reading D. Moore made motion to accept as amended and J. Wright seconded. Motion passed 4-0. Third reading was done and D. Moore made motion, seconded by T. Richardson. Motion passed 4-0.

Ordinance 2006-T-062 Adult Entertainment Regulations – Attorney Fox presented the council with the proposed adult entertainment ordinance 2006-T-62. First reading was done then motion was made by Councilman Moore and seconded by Councilwomen Wright to accept the ordinance as written. The council unanimously voted to have second reading. Second reading D. Moore made motion to accept the ordinance and T. Richardson seconded. Motion passed 4-0. Third reading was completed motion was made by H. Barclay, seconded by T. Richardson. Motion passed 4-0.

Water Business:

Superintendent Getrost stated that the water company is waiting on a bill of sale from Indiana American Homes Water Company for the used pumping station. Attorney Fox noted that their attorney had been ill for the past week and expects the contract this week. Consultant L. Archer is still waiting on specifications before giving an estimate of savings for the project.

Adjustments: Water usage/leaks report was given and reviewed by the council without objections.

Remodeling - T. Richardson ask the council to consider painting and new carpeting for the water utility office area. Councilman Moore noted that the marshal's office is in dire need of major repairs. Moore will get estimates for the police office.

Financial Reports: Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for checks written from the utility and the town.

Old Business:

West 2nd Street Drainage – The council was given an update about the project that should start within two weeks. The survey has been completed and contractor chosen.

Property Ordinance Violations: Attorney Fox gave an update on action being taken against the trailer located on the property on highway 150. The council was given a contract that revoked the fine if the trailer was moved within a reasonable time. The resident had met with Fox and ensured that the trailer would be moved this week.

Property at 6778 Greenville/Georgetown Road: The health department has been contacted about condemning the property by clerk Travillian. The town will need to hold a public meeting in order to finish the process after receiving reports from fire, police and health department.

Committee Report:

Streets and Roads: Councilwoman Wright requested that the town do a study of streets and alleys that need repaving. Councilman Moore will be in charge of the study.

Greenville Town Marshal Report: Town Marshal Rocky Cambron is in training at the Indiana State Marshal's Academy so no report was given.

No further business coming before the Council the meeting was adjourned.
