MINUTES OF TOWN COUNCIL MEETING

October 14, 2002

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller at 7:30 p.m. with Councilmembers David Matthews, Hanzel Barclay and L. Ray Gibson present; Mike Receveur was absent. Also attending was the Clerk Treasurer and Utility supt. Gary Getrost.

Also in attendance was Mr. & Mrs. Bill Smythe, Bob Lilly, Janice Gibson and David Moore.

Ray Gibson motioned the Council dispense with the reading of the September minutes and to approve as written. Council approved 4-0.

Ted Miller introduced Ordinance No. 2002-T-018 titled " Ordinance for Annexation". Ray Gibson motioned the Council accept the Ordinance for consideration. Miller then gave Ordinance No. 2002-T-018 final readings and asked for a vote of the Council. On Call of the Roll Council members David Matthews, Hanzel Barclay, and Ray Gibson voted "Aye". Miller then cast his vote "Aye". Miller then declared Ordinance 2002-T-018, Ordinance for Annexation duly passed by the Council.

Bob Lilly, representing Insight Cable requested the Council adopt a Resonlution titled "Resolution of the Town of Greenville, Indiana Approving the Transfer of the Cable Franchise".

After explanation by Lilly on the merist of such transfer the Council voted to approve the Resolution. Approved 4-0.

Mr. & Mrs. Bill SMythe complained of junk autos, etc. on the property of J. Tush along the alley between U.S. 150 and Clarks St. David Matthews stated he would proceed to have the situaiton corrected if possible.

Council approved: Water bill adjustments in the amount of \$740.55.

Claims for the Utility in the amount of \$54,247.83.

Claims for the Town in the amount of \$4,750.08.

Also approved was the purchase of a laser printer for the Utility.

All of the above approved 4-0.

No further business coming before the Council David Matthews motioned for adjournment.


PUBLIC HEARING - October 14, 2002.




