

MINUTES OF GREENVILLE TOWN COUNCIL MEETING, NOVEMBER 12, 1996.

The regular monthly meeting of the Greenville Town Council was called to order by President Janet Riggs with Councilmembers Ted Miller, Ray Gibson, Mike Receveur and Clerk Treasurer Jack Sprigler attending.

Minutes of the October meeting was read by Councilmember Ted Miller. On call of the roll the Council approved the minutes as read (4-0).

Council President Riggs opened bids for the Utility Backhoe which was declared surplus property at an earlier meeting.

The Council by a vote of 4-0 accepted the bid of Pat Foust for \$ 501.00

The Council approved (4-0) the removal of a tree located on the Town right of way on Clark Street (Ollis property).

Irvin William was present to question the Council on the opening of alleys along Harrison Street to provide access to the Owen property. Mr. William stated he did not believe the previous survey was correct. Councilmember Ted Miller advised William that a surveyor has been contacted to review the previous surveyor's drawing but that the Council has not received a reply. Council will act after receiving this reply.

The Council approved (4-0) an expenditure of \$2,500 to be used for a water study for the IURC to be conducted by Edwardsville Water Utility in order for Greenville to obtain wholesale water rates from Edwardsville.

The Council accepted a proposal from D. Cristiani for field work to be done preliminary to re-design of US 150 at Borden Road. (4-0).

Council approved (4-0) the purchase of 2-way radios for use by the Water Superintendent and Water Utility Operator.
