The board established a monthly rent for the Town of Greenville at \$25.00 per month effective July 1, 1979.

A bill in the amount of \$331.22 submitted by a resident on Smith Road was rejected by the board.

Ms. Haller of the River Region Planning Agency explained HUD grants and asked the board to adopt a resolution directing sugmission of application of HUD grant. On motion by Robert Gibson, Seconded by William Voyles the board adopted the resolution directing Ms. Haller to submit preliminary application to HUD. The board also directed that a public meeting be held December 26, 1979 at 2:30 PM and 7:00 PM for residents of Greenville regarding the HUD grant application.

The board on motion of Pearl Tush, seconded by Robert Gibson adopted a resolution to contract with the Edwardsville Water System for purchase of water, at a rate to be contracted by Mr. Robert Isgrigg.

No further business coming before the board Robert Gibson motioned for adjournment seconded by Pearl Tush.
