

Minutes of Greenville Town Council Meeting June 12th, 2023

Monthly Meeting:

Vice President Andy Lemon called the regular monthly meeting to order. Other Councilperson present was David Gomes, present via Zoom were Kyle Kruer and Skip Powell along with Town Attorney Heather Peters, also present was Superintendent Audi Findley along with Clerk Jack Travillian. Other concerned citizens were also present. Meeting call to order by Vice President Lemon, meeting opened with the Pledge of Allegiance.

Town Business:

Minutes: The minutes for May were not received via email, so the approval will be postponed until next monthly meeting.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The monthly checks were approved.

Committee Reports:

Emergency Services:

Councilman Gomes reported that the new patrol vehicle has not begun to be built, so it is proposed that the contract be voided, we will need to contact the dealership and start the bid process again. Floyd County Sheriff Department has not made changes to weapons so the police department will wait to be compatible when this is completed.

Streets and Roads:

The Community Crossing Grant is scheduled for late June or early July for the town streets. The Schuler Road project with Floyd County has been completed. The sign for one way on Harrison has arrived and will review to see a new post is needed also.

Property Cleanup:

A house on Maple Street in Parkland Heights needs yard care with grass not being mowed, the council will advise the Police department to issue citation. Also, a compliant has been received about abandon vehicles on North Valley View Drive,

Special Projects:

The town's community-wide yard sale was held on June 10, with participation of Greenville Methodist church, Wind Dance and Heritage Springs subdivisions which was highly attended and considered successful.

There is complaints about parking on streets in Heritage Springs subdivision this will need to be addressed in association with Home Owners Association,

Attorney's Report:

Attorney Peters noted that the new fire contract may not be in compliance with state law. Fire District – Highlander Fire District will need contract with the fireman's union,

The New Albany/Floyd County Animal control will be dissolved at the end of 2023, so Floyd County will need a new service provider.

New Business:

A resident of Heritage Springs subdivision will be having a fire works show on July 1, 2023 and is requesting closure of Heritage Way at Wagon Trail to Wagon Trail from 8 PM till 11:30 PM. Motion made by Councilman Lemon and seconded by Councilman Gomes. Motion passed 3-0. Reminder the Town of Greenville is not sponsoring, just supporting the road closure for safety reasons.

Motion by Councilman Lemon and second by Councilman Gomes to close town business, passed 3-0.

Utility Business:

Water Utility

Superintendent Audi Findley the leaks adjustments reviewed were accepted. Last month's water loss was lowered to 19%.

Indian Creek project: E&B will be doing the boring for the replacing water main along side of Highway 150 under Indian Creek. This project is on hold until the lane closure for bridge reconditioning moves to the East bound lanes due to safety issues.

Greenville Water Utility is now in contract to complete the lead and copper inventory of all lines including residential customers and will be sending out questionnaires to help lower the cost of the inspections.

Superintendent Findley last day will be June 30th. Superintendent Findley will be working part time for 20 hours per week at half salary until the new superintendent is in place.

Sewer Utility:

Jecker Excavating & Septic has completed the system jetting and pressure washing of the manholes for preventive maintenance in the Heritage Springs Waste Water Treatment system.

No further business coming before the Council, motion made by Councilman Gomes and seconded by Councilman Lemon to adjourn the meeting. Motion passed 3-0.
