**RESOLUTION CONCERNING THE HIRING OF A TOWN AND
PROSECUTING ATTORNEY FOR THE TOWN OF GREENVILLE,
INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana, in the interest of protecting public interest, has deemed it necessary that the Town develop an Ordinance for the hiring of a Prosecuting and Town Attorney for the Town of Greenville and;

WHEREAS, the current Prosecuting and Town Attorney Mr. Fox because of personnel interest informed the Greenville Town Council at their January 9th, 2012 monthly meeting he was turning in his verbal resignation effective in 60 days and;

WHEREAS, Mr. Fox is involved in two major projects concerning the Greenville Water Utility and it would be a benefit for the smooth transition from one Attorney to another to hire a new Prosecuting and Town Attorney for the Town of Greenville at this time giving 30 days for a transition period and;

WHEREAS, the Town of Greenville Council President Talbotte Richardson has received one resume from Attorney Chris Lane of New Albany, Indiana and;

WHEREAS, the Town of Greenville Council President has not received any additional resumes from interested Attorneys;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. Effective February 13th, 2012 Attorney Chris Lane shall be hired as the Town of Greenville, Indiana, Town and Prosecuting Attorney to replace Attorney Mr. Fox as Town and Prosecuting Attorney on March 12th, 2012.
2. From February 13th until March 12th, 2012 Attorney Chris Lane is to consult with Attorney Mr. Fox to become informed concerning the following topics and projects, New Albany Floyd County Animal Shelter Article 5 services dispute, Water Tower Construction and Sewer Acquisition Projects. Attorney Mr. Fox shall provide any additional information deemed pertinent to the protection of the Town of Greenville to Attorney Chris Lane.
3. Attorney Chris Lane shall preform all legal matters necessary for the protection of the Town of Greenville and prosecute any existing or future Ordinances and Resolutions of the Town of Greenville and the Greenville Water Utility.
4. Attorney Chris Lane shall attend all Town of Greenville, Indiana scheduled Monthly Meetings.
5. Attorney Chris Lane shall attend all Public Hearings, Special Meetings and Executive Sessions as requested by the Greenville Town Council President.
