ORDINANCE CONCERNING THE INCREASE OF CURRENT WATER UTILITY RATES AND CHARGES FOR THE GREENVILLE WATER UTILITY OF GREENVILLE, INDIANA

WHEREAS, the Town of Greenville Water Utility Council for the Town of Greenville, Indiana, in the interest complying with the State of Indiana Code I.C.8-1.5-3-8 Rates and Charges, has deemed it necessary that the Water Council develop an Ordinance which increases Water Rates to reflect increased cost from suppliers and infrastructure requirements and;

WHEREAS, the Town of Greenville Water Utility Council for the Town of Greenville, Indiana, is the entity for fixing and approving rates and charges for the Greenville Water Utility pursuant to I.C. 8-1.5-3 et seq. and;

WHEREAS, after due consideration and discussion after receiving an analysis of current rates and charges and recommendations of O.W. Krohn and Associates at a Special Meeting held on September 28th, 2010 it was further agreed that the water rates and other charges be amended in accordance with appendix "A" attached and;

WHEREAS, Notice of a Public Hearing was published in the New Albany Tribune on October 6^{th} , 2010, and;

WHEREAS, the Notice of the Public Hearing was mailed to all Greenville Water Utility Customers by L & D Mail Masters Inc. of New Albany, Indiana on October 5th, 2010, and;

WHEREAS, Notice of Public Hearing and Proposed Ordinance 2010-W-064 was posted on the Town of Greenville Web-Site {www.visitgreenvillein.com}, and the Greenville Town Hall and Water Utility Offices on October 4th, 2010 and;

WHEREAS; The Public Hearing was held on October 18^{th} from 6:00 - 8:00 pm at The Greenville Elementary School located in Greenville, Indiana;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The metered rates and charges shall be subject to a wholesale water cost tracking factor {WTCF} occasioned solely by changes in the cost of purchasing water for resale from Town's wholesale water providers. WCTF shall be amended from time to time whenever any of the Town's wholesale water providers amend their respective wholesale rate to the Greenville Water Utility. The WCTF will be based upon the total increase in the cost of purchased water, adjusted for the cost of water line losses and Utility Receipts Taxes.

2. In accordance with I.C. 8-1.5-3-8.1 and after the introduction of this Ordinance at the Public Hearing on October 18th, 2010 at which customers of the Greenville Water Utility, owners of property served or to be served by the Greenville Water Utility, and other interested persons may be heard concerning the proposed rates and charges set forth herein. Notice of the hearing shall be published in accordance with I.C. 5-3-1 et. Seq. and mailed in accordance with I.C. 8-1.5-3.8.1. After the hearing the Greenville Water Utility Council may at its next scheduled Monthly Meeting adopt this Ordinance, either as originally introduced or as modified. A copy of the schedule of rates and charges adopted herein shall be kept on file and available for public inspection at the offices of the Greenville Water Utility and the Greenville Water Utility Clerk / Treasurer.

3. This Ordinance shall be effective after it is adopted and published in the New Albany Tribune in accordance with I.C. 5-3-1 through I.C. 5-3-1-9 unless delayed in accordance with I.C. 8-1.5-3-8.2 which allows owners of property connected or to be connected to and served by the Greenville Water Utility to file a written petition objecting to the rates and charges set forth herein so long as {1}the petition contains the names and addresses of the petitioners; {2} the petitioners attended the Public Hearing provided under I.C. 8-1.5-3-8-1: {3} the written petition is filed with the Town Council within five {5} days after this Ordinance is adopted pursuant to I.C. 8-1.5-3-8.2; The signature of petitioners must appear on Public Hearing Sign-In Sheet {4} the written petition states specifically the ground or grounds of objection.

ELEMENTARY SCHOOL, GREENVILLE, INDIANA

To: All Greenville Water Utility Customers,

Last year on or around the month of July 2009 the 60,000 gallon Water Storage Tank located in Galena developed a substantial leak which required emergency measures to repair the tank. Because of this tank failure the Greenville Water Utility Council instructed the Water Utility Superintendent to contract an inspection of the 100,000 gallon Water Storage Tank in Greenville and the 60,000 gallon Storage Tank located in Galena.

Dixon Engineering was contracted in September of 2009 to perform an inspection and report to the Greenville Water Utility Council of the condition of both storage tanks. Both tanks had been installed in 1963 when the Water Utility was first formed. The Greenville Water Utility has routinely performed maintenance on these tanks since 1963. However because of the age of these tanks and OSHA requirements both tanks required major repairs and the cost of repairing would be substantial.

After receiving the report from Dixon Engineering the Greenville Water Utility Council made a decision to research the cost for replacing both of these tanks. The Council contracted Jacobi, Toombs and Lanz Engineering to perform a hydraulic study of the Water Utility System because of customer's complaints of low water pressure and to determine if the current storage tank sizes were adequate for our customer base. When the storage tanks were installed in 1963 they were designed for a customer base of 350. Today the system supports 1,690 customers. The Jacobi, Toombs and Lanz hydraulic study indicated that the current size of the storage tanks was inadequate for today's requirements. Being that the Water Utility is rated as a fire district for the Greenville Township Volunteer Fire Department and the 1,690 customers, it was recommended to meet state requirements that the total water storage tank capacity be 580,000 gallons. Currently between the two tanks in place and their design we only have a total storage capacity of 110,000 gallons. This leaves us 470,000 gallons short of what is required today. The Water Council requested that Jacobi, Toombs and Lanz provide the Water Council with a cost estimate to replace the Water Storage Tank in Greenville with a new 400,000 gallon storage tank. The estimate presented to the Water Council was for \$1,077,250.00. The Greenville Water Utility was established in 1963 as, and continues to operate as a not for profit company. This is the reason that our water rates compared to neighboring communities has always had one of the lowest rates. After receiving this report the Water Utility Council was faced with the dilemma of how to obtain the needed capital to purchase and install this 400,000 gallon storage tank. It was not a question of should we or shouldn't we because we are required by Indiana Code 8-1.5 -3-8 to provide reasonable adequate services and facilities to our customers. The Water Utility Council realized that if we have a major fire in the service area or a power outage as we did in 2008 we would not be able to provide the needed water service to all of our 1,690 customers. During the power outage in 2008 we were within a few hours of not being able to provide water service, but luckily our main supplier was able to locate generators so water service was not interrupted. This may never happen again, but who expected a hurricane to come through this area as it did in 2008 and do the massive damage it caused.

The Water Utility Council decided on a two prong approach. The number one option was to research and apply for a Grant from The Office of Community and Rural Affair's Community Focus Fund of the State Community Development Block Grant {CDBG}. The second option was to apply for low interest loan from the State Revolving Fund Loan Program {DWSRF}. Knowing that both of these programs had certain dates that must be met we held meetings with DWSRF on June 3rd, 2010 and with CDBG on June 10th, 2010 to begin the process. The CDBG required that we hold a Public Hearing on the Grant, which we did on August 10th, 2010 and to provide an income survey that would be reviewed and analyzed by Dr. Frank Wadsworth. Some of you may have received this survey. We were required under CDBG to send out 350 surveys based on the 1,690 customers that we service. The DWSRF required that we hol a rate analysis to indicate that we had enough revenue coming in to repay the loan. The

loan would be at a fixed rate of 3% for twenty years. They indicated in our meeting if our rates would support the loan we would be able to receive it. The Council contracted O.W. Krohn and Associates to perform the analysis. We received the information from the CDBG and Dr. Wadsworth on September 28th that the analysis indicated we would not qualify for the grant. The guideline required that we have at least 51% of our customers at or below the medium income level for this area. We only had 39.4% at or below the medium income level. This has left us with only option two. The Council received the rate analysis from Krohn and Associates at a Special Meeting held on September 28th. The analysis indicates that we must increase the water rates for the Greenville Water Utility Customers to pass on not only increases over the last year from our suppliers, but also to obtain the DWSRF loan. The rate increases proposed by Krohn and Associates shall address three issues. Issue one will be the pass through of rate increases received by our suppliers over the last year. Issue two will be to generate additional revenues for infrastructure repairs that will be required by our aging water supply system. Issue three is the revenue required to replace the Greenville Water Storage Tank with a 400,000 gallon tank. It is also the plan to accumulate the funds needed through the infrastructure rates {we do not have this at this time} to replace the Galena Storage Tanks in the next 5 to 10 years. It is with great regret and reluctance that the Greenville Water Utility Council is anticipating adopting the proposed rate increases. The Council is obligated by law to adhere to State of Indiana Code 8-1.5-3-8. The majority of the rate increase is reflective of rate increases passed onto us by our suppliers. The amount of what your monthly bill will increase depends upon the amount of usage. If any of our customers have any suggestions as to how we can resolve these issues without increasing rates we encourage you to attend the Public Hearing on October 18th, 2010 from 6:00 – 8:00 PM to voice your suggestions. The Ordinance with proposed rate increases shall be posted on the Town of Greenville Web-Site under Public Notices {www.visitgreenvillein.com} and at the Water Utility Office on 9706 Clark Street, Greenville, Indiana beginning October 11th, 2010.



PUBLIC NOTICE TO GREENVILLE WATER UTILITY CUSTOMERS

SUBJECT: INCREASE OF GREENVILLE WATER UTILITY RATES

A PUBLIC HEARING HAS BEEN SCHEDULED FOR OCTOBER 18TH, 2010 FROM 6:00 P.M. TO 8:00 P.M. FOR READING AND THE PUBLIC DISCUSSION OF TOWN OF GREENVILLE ORDINANCE NO. 2010-W-064 ESTABLISHING OF PROPOSED NEW WATER UTILITY RATE CHARGES

LOCATION GREENVILLE ELEMENTARY SCHOOL, GREENVILLE, INDIANA

To: All Greenville Water Utility Customers,

Last year on or around the month of July 2009 the 60,000 gallon Water Storage Tank located in Galena developed a substantial leak which required emergency measures to repair the tank. Because of this tank failure the Greenville Water Utility Council instructed the Water Utility Superintendent to contract an inspection of the 100,000 gallon Water Storage Tank in Greenville and the 60,000 gallon Storage Tank located in Galena.

Dixon Engineering was contracted in September of 2009 to perform an inspection and report to the Greenville Water Utility Council of the condition of both storage tanks. Both tanks had been installed in 1963 when the Water Utility was first formed. The Greenville Water Utility has routinely performed maintenance on these tanks since 1963. However because of the age of these tanks and OSHA requirements both tanks required major repairs and the cost of repairing would be substantial.

After receiving the report from Dixon Engineering the Greenville Water Utility Council made a decision to research the cost for replacing both of these tanks. The Council contracted Jacobi, Toombs and Lanz Engineering to perform a hydraulic study of the Water Utility System because of customer's complaints of low water pressure and to determine if the current storage tank sizes were adequate for our customer base. When the storage tanks were installed in 1963 they were designed for a customer base of 350. Today the system supports 1,690 customers.

The Jacobi, Toombs and Lanz hydraulic study indicated that the current size of the storage tanks was inadequate for today's requirements. Being that the Water Utility is rated as a fire district for the Greenville Township Volunteer Fire Department and the 1,690 customers, it was recommended to meet state requirements that the total water storage tank capacity be 580,000 gallons. Currently between the two tanks in place and their design we only have a total storage capacity of 110,000 gallons. This leaves us 470,000 gallons short of what is required today.

The Water Council requested that Jacobi, Toombs and Lanz provide the Water Council with a cost estimate to replace the Water Storage Tank in Greenville with a new 400,000 gallon storage tank. The estimate presented to the Water Council was for \$1,077,250.00.

The Greenville Water Utility was established in 1963 as, and continues to operate as a not for profit company. This is the reason that our water rates compared to neighboring communities has always had one of the lowest rates.

After receiving this report the Water Utility Council was faced with the dilemma of how to obtain the needed capital to purchase and install this 400,000 gallon storage tank. It was not a question of should we or shouldn't we because we are required by Indiana Code 8-1.5-3-8 to provide reasonable adequate services and facilities to our customers.

The Water Utility Council realized that if we have a major fire in the service area or a power outage as we did in 2008 we would not be able to provide the needed water service to all of our 1,690 customers. During the power outage in 2008 we were within a few hours of not being able to provide water service, but luckily our main supplier was able to locate generators so water service was not interrupted. This may never happen again, but who expected a hurricane to come through this area as it did in 2008 and do the massive damage it caused.

The Water Utility Council decided on a two prong approach. The number one option was to research and apply for a Grant from The Office of Community and Rural Affair's Community Focus Fund of the State Community Development Block Grant {CDBG}. The second option was to apply for low interest loan from the State Revolving Fund Loan Program {DWSRF}. Knowing that both of these programs had certain dates that must be met we held meetings with DWSRF on June 3rd, 2010 and with CDBG on June 10th, 2010 to begin the process.

The CDBG required that we hold a Public Hearing on the Grant, which we did on August 10th, 2010 and to provide an income survey that would be reviewed and analyzed by Dr. Frank Wadsworth. Some of you may have received this survey. We were required under CDBG to send out 350 surveys based on the 1,690 customers that we service.

The DWSRF required that we do a rate analysis to indicate that we had enough revenue coming in to repay the loan. The loan would be at a fixed rate of 3% for twenty years. They indicated in our meeting if our rates would support the loan we would be able to receive it. The Council contracted O.W. Krohn and Associates to perform the analysis.

We received the information from the CDBG and Dr. Wadsworth on September 28th that the analysis indicated we would not qualify for the grant. The guideline required that we have at least 51% of our customers at or below the medium income level for this area. We only had 39.4% at or below the medium income level.

This has left us with only option two. The Council received the rate analysis from Krohn and Associates at a Special Meeting held on September 28th. The analysis indicates that we must increase the water rates for the Greenville Water Utility Customers to pass on not only increases over the last year from our suppliers, but also to obtain the DWSRF loan.

The rate increases proposed by Krohn and Associates shall address three issues. Issue one will be the pass through of rate increases received by our suppliers over the last year. Issue two will be to generate additional revenues for infrastructure repairs that will be required by our aging water supply system. Issue three is the revenue required to replace the Greenville Water Storage Tank with a 400,000 gallon tank. It is also the plan to accumulate the funds needed through the infrastructure rates {we do not have this at this time} to replace the Galena Storage Tanks in the next 5 to 10 years.

It is with great regret and reluctance that the Greenville Water Utility Council is anticipating adopting the proposed rate increases. The Council is obligated by law to adhere to State of Indiana Code 8-1.5-3-8. The majority of the rate increase is reflective of rate increases passed onto us by our suppliers. The amount of what your monthly bill will increase depends upon the amount of usage.

If any of our customers have any suggestions as to how we can resolve these issues without increasing rates we encourage you to attend the Public Hearing on October 18^{th} , 2010 from 6:00 - 8:00 PM to voice your suggestions.

The Ordinance with proposed rate increases shall be posted on the Town of Greenville Web-Site under Public Notices {www.visitgreenvillein.com} and at the Water Utility Office on 9706 Clark Street, Greenville, Indiana beginning October 11th, 2010.

UTILITY OF GREENVILLE, INDIANA

WHEREAS, the Town of Greenville Water Utility Council for the Town of Greenville, Indiana, in the interest complying with the State of Indiana Code I.C.8-1.5-3-8 Rates and Charges, has deemed it necessary that the Water Council develop an Ordinance which increases Water Rates to reflect increased cost from suppliers and infrastructure requirements and; WHEREAS, the Town of Greenville Water Utility Council for the Town of Greenville, Indiana, is the entity for fixing and approving rates and charges for the Greenville Water Utility pursuant to I.C. 8-1.5-3 et seq. and; WHEREAS, after due consideration and discussion after receiving an analysis of current rates and charges and recommendations of O.W. Krohn and Associates at a Special Meeting held on September 28th, 2010 it was further agreed that the water rates and other charges be amended in accordance with appendix "A" attached and; WHEREAS, Notice of a Public Hearing was published in the New Albany Tribune on October 6th, 2010, and; WHEREAS, the Notice of the Public Hearing was mailed to all Greenville Water Utility Customers by L & D Mail Masters Inc. of New Albany, Indiana on October 5th, 2010, and; WHEREAS, Notice of Public Hearing and Proposed Ordinance 2010-W-064 was posted on the Town of Greenville Web-Site {www.visitgreenvillein.com}, and the Greenville Town Hall and Water Utility Offices on October 4th, 2010 and; WHEREAS; The Public Hearing was held on October 18th from 6:00 - 8:00 pm at The Greenville Elementary School located in Greenville, Indiana; NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The metered rates and charges shall be subject to a wholesale water cost tracking factor {WTCF} occasioned solely by changes in the cost of purchasing water for resale from Town's wholesale water providers. WCTF shall be amended from time to time whenever any of the Town's wholesale water providers amend their respective wholesale rate to the Greenville Water Utility. The WCTF will be based upon the total increase in the cost of purchased water, adjusted for the cost of water line losses and Utility Receipts Taxes.

2. In accordance with I.C. 8-1.5-3-8.1 and after the introduction of this Ordinance at the Public Hearing on October 18th, 2010 at which customers of the Greenville Water Utility, owners of property served or to be served by the Greenville Water Utility, and other interested persons may be heard concerning the proposed rates and charges set forth herein. Notice of the hearing shall be published in accordance with I.C. 5-3-1 et. Seq. and mailed in accordance with I.C. 8-1.5-3.8.1. After the hearing the Greenville Water Utility Council may at its next scheduled Monthly Meeting adopt this Ordinance, either as originally introduced or as modified. A copy of the schedule of rates and charges adopted herein shall be kept on file and available for public inspection at the offices of the Greenville Water Utility and the Greenville Water Utility Clerk / Treasurer.

3. This Ordinance shall be effective after it is adopted and published in the New Albany Tribune in accordance with I.C. 5-3-1 through I.C. 5-3-1-9 unless delayed in accordance with I.C. 8-1.5-3-8.2 which allows owners of property connected or to be connected to and served by the Greenville Water Utility to file a written petition objecting to the rates and charges set forth herein so long as {1}the petition contains the names and addresses of the petitioners; {2} the petitioners attended the Public Hearing provided under I.C. 8-1.5-3-8-1: {3} the written petition is filed with the Town Council within five {5} days after this Ordinance is adopted pursuant to I.C. 8-1.5-3-8.2; The signature of petitioners must appear on Public Hearing Sign-In Sheet {4} the written petition states specifically the ground or grounds of objection.
